# **FOCUS: Service**

The first time I heard about "service" in Alcoholics Anonymous was when I was about 3 weeks sober. Someone at the meeting handed me a bag of books and said "bring these back next Friday"...I did this for a couple of weeks until the group voted me in as their literature person for the next term. That first commitment in AA helped me to feel a part of the group...and having a 'job' to do kept me from standing around the meeting before and after socializing, which was so painfully awkward for me early in sobriety.

Service at the group level continued to be part of my journey. From coffee to secretary to treasurer, each commitment helped me learn more about Alcoholics Anonymous and more about myself. When my home group, the Gay Men & Women Together Group, held elections a couple years ago for their General Service Representative I volunteered. The

thought of a 2 year commitment was somewhat frightening. I'd always had a 'fear of commitment' as evidenced by my lack of relationships, and a 6 month commitment in AA seemed just about right for me. I took the plunge anyway and what seemed like such a long commitment at the beginning passed very quickly.

When I attended my first General Service meeting in our district I felt like a newcomer all over again. I didn't know anyone, I didn't understand the format or anything the folks at the meeting were talking about. And just like my first meeting in AA, the people at the meeting made me feel welcome and made me want to come back. I will always be grateful for my DCM Miguel who took the time to explain to me what was going on and for sharing his experience on being a general service rep.

I know being a general service rep continued on page 4

# FEATURE: FORGED FROM ADVERSITY GROUP CELEBRATES 20 YEARS



We named ourselves "Forged From Adversity" for good reason! It began with eviction. Our home church notified the eleven meetings at "Mary and Iowa" in Sunnyvale that they would no longer host AA after February 28. The hassles of dealing with eleven different secretaries, delinquent rents from some meetings, an ongoing problem with cigarette butts, and general disrespect for Church property were cited as reasons. Most of us came to meetings there nearly every day of the week. It had been our place, and we were losing our place. Newcomers and old-timers alike faced a future without our beloved meetings.

On the first Saturday of January, a meeting of all interested parties was called, and the first decision we made was to form a Group, so that the finances, literature inventories, and interactions with a future church home could be centrally coordinated. Group Officers were elected, and structure for the Group began to evolve. A Site Search Committee was appointed, and it was decided we would meet weekly for the next few weeks for status reporting.

By early February, I was in a panic. No new location had been found yet, and I was disgusted and intolerant about the lack of action. Newly sober, I was fragile and hanging on by a thread. I needed my meetings! In a rage, I pulled out the Yellow Pages, turned to Sunnyvale Churches, and started calling. I left messages, explained the need, and was told repeatedly that the Board would consider our request at their next meeting. But finally, providence intervened. I called St. Luke Lutheran Church, 1025 The Dalles, at Wright, in Sunnyvale. The phone was answered promptly on the second ring. I was told this was the minister speaking, and after explaining the situation I heard the magic words, "We have a room available that we've

been wanting to use to serve the Community." They thought they could handle all eleven meetings. My character defects had been put to good use.

March 1, 2003 was the first meeting, with a potluck dinner. There were originally early and late meetings most days. Over the years they consolidated. The church installed a sink in this large room so that we could make our coffee, and put lights in the parking lot so we'd be safe. They welcomed us, made their larger hall available for our Thanksgiving and Christmas Pot Lucks, came to visit us from time to time, and asked repeatedly if there was anything more we needed. In time, they asked us to move to a different room so they could create a space for their teenagers. We moved.

We are now in Kurtz Hall. For twenty years, as of March 1, the Forged From Adversity Group has enjoyed

the hospitality and support of this wonderful church host. Daily meetings are held here at 6 pm Monday thru Friday. On Wednesday another meeting is held at 581 E Fremont at Manet, and another Saturday at 5 pm, Sunday at 7 pm. Pot Lucks every Thanksgiving and Christmas Day, and a great July 4th Picnic at Las Palmas

Park. Everyone is welcome.

By sharing our story, we remember twenty years later how important it is to appreciate the host facilities that make our meetings possible. We remember that when we are rude to a church member, or delinquent in our rents, or careless in our respect for

property, it is AA as a whole that suffers in the impressions others form. And we remember to appreciate the magic of gatherings that happen all over the world, creating fellowship, refuge and recovery for millions of us every day.

I will try to strengthen my mind

I will exercise my soul in 3 ways

I will be agreeable. I will dress becomingly, talk low, act courteously, criticize not one bit, not find fault with anything, and not try to improve or regulate anybody but

I will have a program. I will save myself from two pests: burry and indecision.

I will have a quiet half hour all by myself

I will be unafraid

Point number two was to be happy just for today. It references Abe Lincoln as the source. This is funny because in 1984 I traveled to England for business and I picked up the same card from one of the Central Offices there, and it does not attribute any quote to Abraham Lincoln, rather it states "Just for today I will be happy. Most folks are as happy as they make up their minds to be."

This card still in my possession was published by Inter-Group Central Office in 1975. The address on the card is: 535 Race Street, Suite 130; San Jose, California 95126; 408 297-3555. I treasure the little card today, 37 years later, because its principles are simple and true.

# **SERVICE; AKA: The Yum Yum Girl**

Being an alcoholic, I've been called a lot of things in my life -- most I prefer not to repeat. However, since coming into AA's halls and rooms I've been called some rather sweet, funny and memorable things.

My last time back through AA's doors saw me throwing myself straight into service; I figured if I stayed busy I'd be more likely to stay sober! Since coming back into the accepting family of AA, I've realized what an important Service it is to my fellow AA comrades to simply attend and be present at meetings. I find it amazing how God works through His cadre of recovering alcoholics to allow messages to be: relayed, heard, delivered, conveyed, exchanged --- add your verb here.

One of my Service commitments is to clean-up the meeting room after the meeting is over. This is not difficult and allows me time to linger with purpose whereas before I thought I had no reason to linger and would therefore rocket out the door like a pebble shot from a sling shot. My clean-up duties rarely take more than 15 minutes. Another Service I have is to set up the meeting hall before the meeting begins. Again, this is simple to do and the time

requirement will be proportionate to the size of the meeting space. One of my simplest Service commitments is to buy a birthday cake for the end-ofthe-month sobriety-birthday celebration from a nearby store, bring it to the meeting and get reimbursed for the expense. It is so easy and yet it brings such smiles to everyone's faces when they see the "Happy Birthday" cake.

I believe Service gives us a chance to acclimate to our new surroundings if we are newcomers or to more fully enrich our AA experience if we are not. It is also a way for us to gradually feel safer and allow ourselves to know the vast and expanding members of our AA family better. More than one of the members of my expanding AA family called me "The Yum Yum Girl" when I brought donuts to several meetings in a row. Playful nicknames, from people that only want good things for me, are just one of the perks of my life in AA. So many people are verbally appreciative; it is hard to leave a meeting where I have been Of Service without feeling better - lighter somehow.

Don't just take my word for it, though. Ask any one of us in AA and he/she will be happy to tell you that Service is an important and meaningful part of our AA lives. Some members feel very strongly about Service. Some believe it is one of the best ways to stay sober.

There is simply something magical about being of service. I say "Of Service" instead of "In Service" as I hear two wholly different meanings between those two tiny two-letter prepositions. "In" Service says to me I MUST do something whereas "Of" Service says I have a choice and therefore I GET TO do something.

I don't know about you, but this alcoholic does not take kindly to "must". Must makes my teeth grind and my eyes squint (think Clint Eastwood in any Dirty Harry movie). "Harry C." and I would say "Make my day, punk" if Service were a must. Thankfully, and I mean this sincerely, Service is only a suggestion. If Service is merely a suggestion, then I have a choice as to whether or not I want to do it and if so, how often.

There is such a diverse array of Service choices I feel like a kid in a candy shop -- I hardly know where to point first. Some forms of Service require a certain length of consecutively sober days; however, there is still a plethora of choices for the newcomer (and old-timer), which may be done as early as one's first meeting.

Each selfless act Of Service brings you closer to your AA family and (hopefully) a little farther away from that bottle.

In addition to the aforementioned ways to be Of Service there are far more avenues to explore and tasks that may be done. The person that makes the coffee is Of Service. Our Hospital & Institution representatives are Of Service as are our PI/CPC representatives. The individual chairing

the meeting you attend is being Of Service, as is the Secretary running the meeting you attend. If you've ever been asked to read: How it Works, The Promises, or The 12 Traditions, at the beginning of any meeting, then you have been Of Service.

These are only a meager few examples of Forms of Service available to any alcoholic. It is so easy to be Of Service -- plus it has the added benefit of making you feel good about yourself while being a contributing member of AA. For an alcoholic like me, this is simply one of the best Win-Win situations in which I could put myself.

So remember, when it comes to Service there are tons of choices and they are all yours to make. If anything sounded interesting to you, I hope you will try it out.

Service is defined as "an act of helpful attend regularly. There are a whole activity; help; aid." It is the third legacy given to AA by its founders. In talking about that third legacy, Bill W. said that "AA is more than a set of principles; it is a society of alcoholics in action." I see a theme here... Action! Service is action. So you could ask,"What are your actions in AA?" It seems that everything we do in, for, and around AA and recovery could be considered service.

Well, I go to meetings. It'd be hard for one alcoholic to share his or her experience, strength and hope if there was no other alcoholic with whom to share it. And in those meetings, I offer my thoughts on the current topic when called on. Who knows? Even my crazy experience might resonate with someone yet to walk a path I've already trudged. I also hold service positions at meetings that I

I'm a sponsee. Gosh, how could my sponsor be a sponsor without a sponsee? There's certainly a ton of action involved in being a sponsee. And it really is service to my sponsor for me to be a sponsee. I know this, because I'm also a sponsor. There are gifts I've been blessed with by sponsoring others that I'd have never known had my sponsees not signed up for their service. Service to me and to themselves.

My biggest service in AA, though, and my most benevolent action in and out of the rooms, is my behavior.

My behavior has changed considerably from that of both my drinking and my non-drinking days prior to becoming a member of Alcoholics Anonymous. Through the processes of working the steps and working with others, my "standard mode of operation" has become less selfcentered. I certainly have a soft spot in my heart for my fellow recovering alcoholics, but I also have compassion and tolerance with those I encounter outside our fellowship. Living by the principles of our program, I am able to serve all of my fellows by adding something favorable to their day at best, and by not being a negative influence at least.

Service has created a wonderful cycle in my life: Because I think better of myself, I think better of others. Because I think better of others, I feel better about myself. I think that's the greatest thing about service and the actions that it's comprised of... it's a win-win deal! -- Anonomous



# **Editor's Bag**

In April 1939, 5,000 copies of the Big Book of Alcoholics Anonymous were printed, anticipating a strong reaction to a publication from the Reader's Digest as well as a radio announcement, which didn't materialize. Although the initial disappointment in the sales of the AA Big Book was great, they continued to persevere in spreading the word. The Jack Alexander story didn't appear in the Saturday Evening Post until March, 1941, when it generated a huge demand for the Big Book. In 1955 there were approximately 100,000 members of Alcoholics Anonymous, and by 2000, the estimate was 4,000,000. The promises do come true: "Sometimes quickly, sometimes, slowly, they will always materialize if we work for them."

This month's Tradition Four is "Each group should be autonomous except in matters affecting other groups or AA as a whole." Well, what the heck does that mean, anyway?

It means independent, self-directed, self-sufficient, selfgoverning, self-ruling, or sovereign. Which means, GROW UP. Pay your own way. Don't rely on others. Take care of business in all things, just like our parents (or perhaps our sponsors) taught us, and how we teach our own children -- to become adults. We set up the guidelines and have everyone follow them as a unit. We govern ourselves.

I just had the privilege of witnessing my younger daughter's wedding on a beach in Maui this month, and I was so proud of that "child" of mine. She truly did it her way no big money spent for a wedding, just a simple ceremony



performed on the beach by a Hawaiian "kahuna" blowing a conch shell to announce the marriage. It was delightful, and she was radiant. I was honored to be invited, and grateful this child turned out, after a few attempts at frogkissing, to find exactly the right guy for her. Both families are entranced at their union, which didn't cost anyone a right lung, and we all got to vacation where we may never have planned to be otherwise. 

# MY HIGHER POWER

On Page 63 in the Big Book of Alcholics Anonymous, it reads:

"When we sincerely took such a position (quit playing God), all sorts of remarkable things followed. We had a new Employer. Being all powerful, He provided what we needed, if we kept close to Him and performed His work well. Established on such a footing we became less and less interested in ourselves, our little plans and designs. More and more we became interested in seeing what we could contribute to life. As we felt new power flow in, as we enjoyed peace of mind, as we discovered we could face life successfully, as we became conscious of His presence, we began to lose our fear of today, tomorrow of the hereafter. We were reborn."

"We were now at Step Three. -Many of us said to our Maker, as we understood Him: 'God, I offer myself to Thee—to build with me and to do with me as Thou wilt. Relieve me of the bondage of self, that I may better do they will. Take away my difficulties, that victory over them may bear witness to those I would help of Thy power, Thy Love, and Thy Way of life. May I do Thy will always!' Wwe thought well before taking this step making sure we were ready; that we could at last abandon ourselves utterly to Him."

When I was a kid between the ages of eight to ten, we went to church, and the stories in the Bible weren't personal enough for me; I couldn't relate to a God. My dad had been an athlete all his life, and I was expected to do well in school, since I had a high IQ and was a straight A student.

When I was about 11, I worked in a pool hall as a janitor (to improve my pool game.) Right around that time, my folks got divorced, and I started sniffing glue in junior high, which progressed into other things, and I

immediately got into trouble. Quit going to church. I took more drugs.

I still was a straight A student before high school; I took pre algebra in summer school. By the end of my freshman year I was the kid in back of the room, sleeping. Didn't care about school; didn't want to face my parents being divorced. Took methamphetamines all day, smoked marijuana, and drank.

Went to college, took mechanics, switched to business, got a job in computer sales, and made a lot of money. In 1976 I got married, doing great in my own business. Continued to take drugs and drink. In 1980, our daughter was born in April and in June of that year I was in an auto accident on my way home from a game of golf.

A drunk driver rear-ended me, sending me into the windshield and through the rear-view mirror. I was in a coma for six months and in the hospital for a year, having to learn how to walk and talk and eat and help my brain to work in every way. My mom prayed for me every day to recover. During that time and when I was released from the hospital, my wife divorced me.

For twenty years I was angry, but dry (I couldn't take medication and drink) so I continued to be inappropriately angry at everyone. One day I really wanted to harm a stranger, and I heard God say, "Stop; Go to AA." That was the beginning of my sobriety.

Went to church after divorce; I couldn't make sense of what I was hearing due to medication and not being able to connect. When I got to the point that I WAS making sense of it, people started to notice that I was doing better. Today I have thirty-three years of sobriety.

I hear God speak to me (yes, I know it sounds loony, but I do.) Every morning I ask, "Where do you want me to go?" And I listen; whatever appears to be the answer before me, I do. Sometimes I hear, "Go to Santa Cruz." And I'll go there; one day I did the opposite, and got on a bus and heard, "The woman next to you is having an affair with a guy in Oakland." I started a conversation with her, and she said she'd gotten on in Oakland, and I KNEW this was where I needed to be. God had whispered, "Don't mention the affair." So I listened to her tale, then I told her my history that related to her story as her life unfolded in front of me. When we were just about at the end of the bus trip, I asked if she'd like to pray with me, and she said, "I would. I was seriously considering killing myself today when I got home." We prayed and the feeling was removed from her. Is this God?

One day it was San Francisco: "Shall I go?" "Just go." (It takes a couple of hours.) Bus/train/walking. I walk by this guy who's standing on the sidewalk. I tell him: "God loves you." And the guy says, "Tell me more" so I said, "Okay. Are you hungry?" He said he was, so we went into Subway to get a sandwich, and he told me he was considering stepping in front of a bus that day, but I stopped that thought for him.

I think it's my Higher Power. At the Rincon meeting one day, I met a new guy, and after I'd talked to him for a while, he said he had lost the desire to kill himself. Now he has four years of sobriety.

This one is about patience: a lady in a wheelchair wants to board the Santa Cruz bus I'm on, and I'm impatient because I'll miss my connecting bus. We get five minutes down the road, another wheelchair boards the bus,

The first meeting at this location was held on November 9th 1946. It is currently known as the Trinity Group, but was initially called the Saturday Night Group. It was an open meeting where family members and friends of the alcoholic were encouraged to attend and participate. The meeting moved a couple of times in the first few years, but returned to Trinity Episcopal Church in 1952 and has remained there ever since.
